+++ International Humanitarian Award +++

+++ AM Privileges -- Under Attack? +++

Definitely not!

A few members contacted me with questions about the possible impact on US hams of a bandplan adopted by Region 2 of the International Amateur Radio Union -- IARU. The answer to the question is that the Region 2 bandplan has no impact on US hams.

For background, the IARU is the International organization of national Amateur Radio societies from around the world. These societies include the Radio Amateurs of Canada (RAC), the Radio Society of Great Britain (RSGB) and the ARRL. Region 2 of the IARU covers the Western hemisphere. IARU cannot issue legally-binding rules or regulations.

There are three regions in the IARU. Each of the regions has a voluntary bandplan. The Region 1 and Region 3 bandplans preceded the Region 2 plan. IARU Region 2 held a conference a few weeks ago. Among other actions, it adopted its new recommended bandplan during this conference.

It is critical to understand that this recommended bandplan has absolutely no relevance to countries such as Canada and the US which have federal agencies (*e.g.* the FCC) that define and regulate Amateur Radio bands. In addition, IARU bandplans are merely recommendations to amateurs in countries that do not have such government agencies. There is no force of law behind the voluntary bandplans.

The concern of some amateurs seems to be that the FCC will adopt the Region 2 bandplan; thereby reducing the US's frequency allocation for AM. One writer from the GLD said the FCC has previously adopted a number of practices recommended by the IARU. To this moment, he has not responded to my request to identify just which IARU recommended actions were picked up and adopted by the Commission.

Similarly, a writer from outside the GLD has accused IARU President Larry Price W4RA of a written attempt to manipulate International Treaty to reduce AM privileges. To date, he too, has not responded to my request for a reference to the source of his accusation.

Finally, *CQ Magazine* has jumped into the fray by accusing ARRL of using the recent IARU Conference to further regulation by bandwidth. I enjoy

reading CQ; however, as much as I enjoy reading it I equally strongly assure you that its editor has gotten caught up in bad journalism. The basis for the editorial appears merely to be ARRL's publicly-acknowledged support of regulation by bandwidth and the fact that the Region 2 bandplan specified bandwidths. This logic is similar to claiming 1 plus 1 = 6.

The fact is that ARRL did not participate in developing this bandplan.

We had no representation on the bandplan committee. Could it be that in reality, the plan was developed in The 2-Jiver, Oh-Ky-In ARS, December 2007, page 10

its present form because the delegates who drafted it believe this is the way it should be and that there was no dastardly conspiracy after all? Or is it too hard to believe in this day of ever-present conspiracy theories is it too much to expect that some things are done in a fully responsible manner?

The bottom line to this small flurry of concern by some AM colleagues is that the Region 2 bandplan represents nothing to worry about. The IARU has no impact on US FCC regulations . . . the FCC has no apparent intent to act against AM in the foreseeable future . . . the ARRL has no thought of recommending the FCC take action against AM . . . and I will vote against any effort to get ARRL to recommend action against AM.

My recommendation to AM operators is to relax and enjoy your favorite form of Amateur Radio . . . for a long time.

+++ BPL and Related Issues +++

You will recall that the ARRL has brought suit against the FCC in Federal Court in the District of Columbia. Although BPL is listed as the prime issue in the suit, it is far from the only issue. The issue that is at least equal to BPL is FCC's ruling that give Part 15 devices (including BPL) precedence over licensed radio services such as Amateur Radio under some circumstances. Part 15 devices are not licensed and have previously been allowed to radiate signals only provided they did not cause interference to licensed services. ARRL's day in court was a couple of weeks ago. We don't expect to hear anything from the judges for up to six months. If we win, we expect the Court to direct the FCC to review its decisions concerning BPL. In this situation, we would expect FCC to develop BPL regulations that are more realistic and consistent with the historic action of the Commission. It is not a guarantee either that we will win or that our expectation will be fulfilled if we win.

Still on the topic of BPL, we may be seeing the early stages of its novelty wearing off. The FCC reported there has been a sharp decline in the number of homes using BPL for the past year. Consistent with this observation, Duke Energy announced it will not expand its current use of BPL. Duke also said it has no plans to discontinue BPL in present markets such as Cincinnati.

The final comment on BPL is that the new installation for the Lansing MI area is reported to use a "non-interfering" version of BPL. The BPL provider has worked with the ARRL laboratory in developing its system.

+++ ARRL Committee Studying Field Organization +++

Many of you may be aware that the Programs & Services Committee of the ARRL Board has been tasked with studying the governance of the Field Service organization. As a member of this Committee, I can say that we are reviewing the present design and operation of Field Services to see if changes or improvements should be made.

As one phase of the Committee's search for information, a survey was taken of the 73 Section Managers in ARRL. Similarly, Board members and officers were surveyed.

Nothing in the study has been predetermined. The study has not been set-up to obtain pre-designated conclusions and actions. All aspects of the field organization are being reviewed.

+++ Director - Vice Director Elections Ahead +++ print size reduced to 9-point to save space Elections for the Great Lakes Division Director and Vice Director will be held next year. Even though the call for nominations will not be made until July and August, it is not too early for members to consider making a run for either of these offices.

As usual, I encourage eligible members to run for office. I especially encourage members who are dissat-isfied with the way I have been performing the duties of the director to toss their hats in the ring.

Similarly, I encourage people who feel they can perform the duties of the Vice Director to run for this office.

ARRL is a democratic organization. I firmly believe that members who do not run for office or do not vote in ARRL elections have no right to complain about decisions elected officials make. Although the topic at this moment is the election of directors and vice directors, I hold the same opinion regarding the election of section managers.

The following excerpt from the ARRL By-Laws addresses most aspects of elections for Director and Vice Director. I thought everyone should have the opportunity to become aware of this important information.

"17. Each director shall keep himself informed as to conditions and activities in his territorial division and as to the needs and desires of the members therein in order that he may faithfully and intelligently represent the true interests of such members. He shall attend all meetings of the Board. At least 14 days prior to each annual meeting of the Board of Directors each director is encouraged to file with the Secretary a written report on the status of the affairs of the League in his division, together with a statement of his recommendations as to any actions required for the effective administration of the objectives and affairs of the League.

"18. In the July and August issues of *QST*, the Secretary shall solicit nominations for the office of Director in each division in which the term of the incumbent is to expire on the subsequent January 1, in a notice that shall include the name of the incumbent. On any date between the appearance of the first solicitation for same in *QST* and noon Eastern Time on the second Friday of August of any election year, any Full member of such division may request official nominating petition forms. To constitute a valid nomination, the original copy of such an official nominating petition form as provided by the Secretary must name a Full member of the division as a candidate for Director; must be signed by ten or more Full members of the division; must be accompanied by a statement signed by the candidate attesting to his eligibility, willing-ness to run, and willingness to assume the office if elected; and must be filed with the Secretary no later than noon Eastern Time on the third Friday of August of that year. Only original documents shall be accepted by the Secretary, and he is not authorized to accept facsimiles of any kind. The Secretary shall immediately acknowledge the receipt of nominations to the candidate, and shall forward the nominations to the Ethics and Elections Committee.

"19. The Ethics and Elections Committee shall delete the name of any nominee who may be ineligible to election and the name of any who may withdraw by written communication. The remaining names shall be listed on a ballot, in alphabetical order. If there be but one eligible nominee, the Ethics and Elections Committee shall declare him elected without balloting by the membership. If there be more than one eligible nominee, then on or before October 1 of each year the Secretary shall send by mail to every person who on the tenth day of September of that year was a full member of the League in the divisions in which

elections are being held, a ballot listing the candidates for director in his division, and a return envelope, soliciting a vote for one name. The ballot shall contain a copy of By-Laws 18 and 20.

"20. The Ethics and Elections Committee shall appoint a committee of three tellers including at least one director and shall arrange to have a certified public accountant present to certify the results of the ballot- ing; but any member of the League who shall deliver to the Secretary on or before the first day of October of election year a written petition signed by at least ten full members of a division, stating their desire that he witness the counting by the committee of tellers of the ballots from that division, shall be permitted to do so and shall be accorded reasonable opportunity to satisfy himself of the correctness of the count reported by the committee. Ballots, to be counted, shall reach the mailing address established for their return no later than noon Eastern Time on the third Friday of November of election year. No outer envelopes marked as containing ballots shall be opened until the meeting of the committee of tellers held for the purpose of counting the ballots. The committee of tellers shall meet at the headquarters office of the League as soon thereafter as possible and in the presence of each other shall open the envelopes containing ballots and shall count the vote, after first eliminating the ballot of anyone disqualified from voting. They shall forthwith prepare and sign in the name of the Ethics and Elections Committee a report of the results of the vote, declaring duly elected as new directors the candidate in each division receiving the greatest number of votes therein; and they shall turn over all their records and ballots to the Secretary for presentation at the next annual meeting of the Board of Directors." In addition to other considerations, a candidate for director or vice director must have been a licensed amateur and a full member of ARRL for four continuous years. Licensing and membership must continue throughout the elected term of a successful candidate.
