

++ Preparing for next ITU treaty meeting ++

ARRL CEO Dave Sumner K1ZZ, former Board President Larry Price W4RU were in Geneva, Switzerland the week of June 11 working on preparations for the 2007 national Telecommunications Union (ITU) treaty conference. The conference will be held this fall. Price is a former Board President and is the current President of the International Amateur Radio Union (IARU).

The official US Department of State delegation to the conference (WRC07) will include ARRL Chief Technical Officer Paul Rinaldo W4RI and Jon Siverling WB3ERA of the ARRL Technical Relations Office.

Amateur Radio has gained additional frequencies or as been the recipient of decisions to reduce QRM on frequencies through recent ITU Treaty conferences. The International Amateur Radio Union (IARU) is developing strategies to continue this trend.

++ Bonehead letters from Congressmen's Aides ++

A few of you have received what I call bonehead letters in reply to the letters you wrote supporting HR 462. The letters thanked you for writing about some Copyright Fee issue or anything other than HR 462.

I call these bonehead letters. These are canned letters that were printed out by a busy aide who failed to read the letter to which they were attempting to respond.

A common conclusion you may reach is that writing to the Congressman was a waste of time. I'm here to say this is far from the truth. How can I say this with a straight face?

Remember that I asked you to send copies of your letters to Dave K1ZZ or, later Janet Worthington of Chwatco . . . and me. If you did this, your effort wasn't wasted regardless of the reaction you received to it. Here's why. First of all, purely and simply, writing to Congressmen works. One letter may not work, but depending on the issue, as few as a dozen letters will get the Congressman's attention.

Second, letters that are followed up in Washington by our lobbyist really get a Congressman's attention. When a lobbyist walks into a Congressman's office to educate him/her on a bill, they carry the copies of all the letters they received that were sent to the Congressman. Even if an aide miscataloged letters received from constituents, the lobbyist has the names and addresses of the writers. This information corrects any misinformation the aide has, and opens the door for the lobbyist to tell our story, face to face.

What you constituents have done in writing, is to put your faces on the legislation -- faces of voters -- faces that have opinions and wishes. Faces of people the Congressman wants to vote for him in his next election.

When the cause we promote has no partisan political baggage hanging onto it, there is high likelihood the Congressman will be inclined to support this cause. Issues ARRL selects to support or oppose do not have partisan political baggage associated with them.

The bottom line is that your letter (give it 1 point) plus a copy of your letter (give it another 1 point) plus the face-to-face use of your letter by our lobbyist (still another 1 point) all add to 6 points of leverage with the Congressman. We don't expect a Congressman to reply to your letter by saying he/she will support the bill. We don't even expect the Congressman to see your initial letter. What we expect is that your letter will open the door to the Congressman's office in DC to our lobbyist who will carry the final part of the battle.

Keep on writing. You and your action are the key to the success of our lobbying effort. We can compete in the world of Washington with your help. Without your help, we are dead in the water. We don't have the finances to compete the other way. Unlike us as individuals, ARRL is prohibited by IRS rule from making monetary gifts, anyway. ++ Excellent Reply to Bonehead Letters ++

William "Pat" Hartlage NA4NA received a bonehead letter in response to his letter on HR 462. He knew the letter was sent by an aide who was probably pressed for time and became a little careless. Pat decided to attempt to educate the aide -- and the Congressman – by sending the following letter. It is a good one. He offers it as a starting draft for any of you who have had a similar experience. Please modify the letter and send it to your Congressman when the situation warrants. Pat's letter is:

"Congressman (name),

"I appreciate your office giving me a reply to my (date of your first letter) message regarding HR 462, the "Emergency Amateur Radio Interference Protection Act." Unfortunately the response your staffer prepared, which is included below, was unrelated to the issue I wrote you about.

"Let me add that I understand the number, range and complexity of issues your staff handles far surpasses anything I experienced, and mistakes happen.

"Would you please reread my original message? It provides detailed arguments as to why a comprehensive study of broadband over power line (BPL) technology is needed. Rather than repeating the arguments here let me observe in summary that the current FCC policy makers appear to have started with a conclusion before getting all the facts regarding BPL and have ignored longstanding communications policy and law regarding harmful interference to licensed services from some BPL operations.

"Best wishes,"

(Your signature)

(Your name and address)

Although Pat's letter obviously relates to HR 462, it can easily be modified to apply to any of the legislative we will promote or oppose.

++ LOTW Server Upgraded ++

The server for Logbook of the World (LoTW) has been updated. As some of you may know, the upgrade was accomplished recently by taking Logbook out of service for a couple days.

The main benefits of the upgrade are faster processing and increased storage. An upgraded operating system and relational database software (RDMS) make the improved operation possible. The increase in storage took a system that was using nearly 90% of its available storage to where it uses only about 45% of the storage.

++ Son of HR 462 goes to US Senate ++

I am very pleased to be able to announce that Sen. Mark Pryor of Arkansas has sponsored a companion bill to HR 462 that is in the US House. The Senate version of the bill has been numbered S.1629.

Do not write about the Senate bill, yet. The time for this will come later. We'll let you know when.

Until the time comes, if you haven't written to your US Representative to support HR 462, please do. We continue to do better every day, but we are far short of demonstrating the true strength of Amateur Radio to our Representatives.

If you need any of the information I previously sent to you, please let me know. I'll be happy to resend it. The main thing is for every member -- and their friends -- to write to their US Representatives.

++ More BPL Comes to Michigan -- and? ++

A California company has partnered with Consumer Energy of Central Michigan to provide BPL. The ultimate goal is to move BPL nationwide. The Michigan installation should not cause problems to amateur frequencies. Watchful waiting is the word for the day.

The coming system is scheduled to use Kaicom equipment and operate on 2-34 MHz. A review of the equipment by Ed Hare W1RFI, the ARRL Lab Manager, shows it contains notching so it can avoid QRMing all ham frequencies. Of course, proper operation of the equipment will be needed to avoid QRMing ham frequencies.

When improperly operated, the equipment can cause interference. However, in the spirit of watchful waiting, anyone who believes they are experiencing BPL QRM should be doubly cautious to avoid making unsupported complaints against the system. We need to avoid damaging our own credibility.

As Dave Sumner K1ZZ said, we must not "put ourselves in the position of the neighbor who complains about RFI when the tower goes up but before the transmitter is connected."

Of course, SM Dale Williams WA8EFK and his crew of BPL watchers in the Lansing area are already on the job, prepared to work with Consumer Energy to monitor the new system as it develops. The local BPL oversight committee will coordinate closely with W1RFI through its operation.

==> ARRL Membership Numbers on the Rise

With now close to 152,000 members, the ARRL is going, and growing, strong. ARRL Customer Service Manager Amy Hurtado KB1NXO says the "ARRL is a viable, up-to-date organization that every ham should be a part of." Hurtado credits the rise in membership in part to the FCC rule changes earlier this year that eliminated Morse code testing for the General and Amateur Extra license classes. "Since more people were upgrading their licenses as a result of there being no Morse code requirement, we were successfully able to show them the benefits of being an ARRL member," she said.

One of the many benefits of ARRL membership, Hurtado said, is the monthly subscription to QST, the official journal of the ARRL. Other benefits of ARRL membership include a QST/QEX/NCJ index search on the ARRL 7he 2-Jiver, Oh-Ky-In ARS, July 2007 page 12

Web site; operating awards; outgoing QSL service; access to the Technical Information Service; available ham radio equipment insurance program and more. Members can also get an *arrl.net* e-mail address through the ARRL e-mail forwarding service.

Hurtado went on to say that new, renewing and lapsed members can join the ARRL in many ways. "About 40-50 percent of membership enrollment is online. We also have people join after taking a licensing exam, by calling us on the phone, by answering a direct mail package or by joining up at their local hamfest."



Tate is serving out the remainder of the term of former FCC Chairman Michael Powell. Current FCC Chairman Kevin Martin said of Bush's announcement, "If confirmed, I look forward to continuing to work closely with Commissioner Tate. She has served admirably at the Commission for the past year and a half, and I appreciate her continued dedication to public service. Debi brings important insight to the Commission, including her distinguished career as a leader in state government. Her thoughtfulness, dedication, and leadership have made Debi an invaluable member of the Commission." Among her many responsibilities, Tate serves as Chair of both the Federal-State Joint Board on Universal Service (Universal Service Joint Board) and the Federal-State Joint Board on Jurisdictional Separations.

* ARRL E-Mail Usage Going Strong: One of the many benefits of ARRL membership is the ARRL e-mail forwarding service, first offered in February 1999. This service allows ARRL members to set up an arrl.net alias e-mail address. When e-mail is sent you at your arrl.net address, it is forwarded to an e-mail address you have designated. According to ARRL Information Services Manager Don Durand, approximately 45 percent of ARRL members take advantage of the e-mail forwarding service. "Using the figures from Wednesday, June 20, we had 876,993 connection attempts and 148,400 actual e-mail deliveries," Durand said. "The difference of 728,593 represents spam that was trapped and not delivered to our members." Durand said the numbers show the e-mail filters do a "pretty good job eliminating spam. Using a combination of filtering software, as well as holding in-bound messages to the accepted standards of transmittal, we are able to remove approximately 90-95 percent of all spam before it reaches a user's inbox."
