How many Hams in a State?

Well, that depends on which State (or Territory) you are asking about. Our own state of Ohio has about 28,198 licenced Amateurs. Our neighbours to the north in Michigan number about 20.167. California leads the count with 91,118, while the Virgin Islands have only 237. Could this be why you have to work a little harder for a VI contact than a west coast one? It has been said "everything is big in Texas", but they rate a distant second place with 43,072, just ahead of Florida's 38,163. To round out the top 5 we have New York with 28,293 and Ohio in the very close 5th position. These numbers were good on January 23, 2007, so we may have moved up a notch or three by the time you read this. On that date the total number of hams in the USA was 655,359.

Code testing for licensing

Like it or not, testing for Morse code proficiency to obtain General and Extra Class licenses ended February 23. This is the date by which all amateurs interested in the future of Amateur Radio need to come together to welcome new licensees and upgrades. We all need to show interest in the "new" ones and mentor them to be good hams. To fail to do this could prove very troublesome to our great radio service. *Who did it?*

HQ organization changes, continued from last issue.

In the last issue of my Words, I discussed primarily how recent organizational changes at HQ impacted Dave Patton NN1N and the DXCC program formerly managed by Wayne Mills. In this issue, I will address the impact of the changes largely on the Field & Education Services organization headed by Dave Patton NN1N. I discussed the easiest change first.

In essence the Membership Services Department (F&ES) and the Membership Services Department (MSD)were essentially rolled into one department that has been named the Membership & Volunteer

Programs Department (MVP). In doing this, our Regulatory Services specialist who had previously reported in through F&ES has been shifted over to report directly to CEO Dave Sumner. This tidies things a little because Dave clearly has the lead at HQ in developing regulatory strategy and relaying regulatory actions by FCC, the ITU and other groups to ARRL members.

Two additional changes in the old F&ES Department are underway. First, more attention is being given to developing educational materials. You who have seen the new Technician License manual and one or two additional new teaching aids have already seen how this new emphasis is working out. There is much more to come.

The second change is the addition of a new position as EmComm Director. The duties of the new director have been described in the National Emergency Response Planning Committee (NERPC) Report that was ratified by the Board in January. The EmComm Director is to develop the emergency communication skills possessed by ARES members and organizations throughout the country into the finest EmComm organization in the world for meeting the needs of large-area disasters such as Hurricane Katrina. We want to be the best and to be perceived as being the best -- no exception. Local ARES groups remain very capable of managing local situations.

Ohio LAC appointed

Brent Stover WD8PNZ of Maumee, Ohio has been appointed Legislative Action Coordinator (LAC) for the State of Ohio. Brent follows Jim Ashman W8ASH who retired from the position late last year because of personal reasons. Brent has been Legislative Action Assistant (LAA) serving the Ohio Ninth Congressional District. His first task is to develop the Ohio Teams of Legislative Action Assistants in each Congressional District in Ohio. Red Cross modifies position

In a letter to Red Cross officials throughout the country, Jack McGuire, Interim President and CEO and Kate Forbes, National Chair of Volunteers for the American National Red Cross have changed their former stand concerning background checks for all Red Cross volunteers.

The revised position is:

"- A new consent form will be developed that eliminates all references to credit checks and mode of living.

"- The Red Cross will not run future credit checks or mode of living checks on anyone who has signed the previous consent form. The Red Cross will consider that consent form null and void as to the credit check and mode of living authorizations, and promises not to conduct credit check on individuals unless we obtain a second consent form from them authorizing those checks. Mode of living checks will not be conducted under any circumstances.

"- In an effort to establish and maintain consistency across the organization, Jane Gilbert, Senior Vice President, Service Area Support, will convene a working group to establish an ongoing credit check policy that will define which positions require a credit check in the future and how to evaluate credit checks for those positions."

I applaud the Red Cross for recognizing the demand to sign the previous, inclusive background check authorization was inappropriate. I previously notified the Cincinnati Red Cross Chapter I authorize a criminal background check on myself. As soon as the reformatted authorization form that limits the requested background checking to a criminal check becomes available, I will sign it.

As of the date this issue of Words is being released, there has been no public statement by the Red Cross concerning the change in background checking. Similarly, the promised reformatted background checking release form has not yet been issued.*Weaver's words continues on page 9*

Suggestions for DX Pile-ups..... by Uncle DX

1. The DX station operators are in charge of any pile-up.

2. The DX station should make and adhere to their operating rules quietly and respectfully.

3. The DX station should use, when appropriate, call areas and areas of the world for better accuracy, rate and order.

4. The DX station should use split operation and spread stations out, keeping in mind others not in the pile-ups. A must.

5. The DX station should give their call sign at least every 10 minutes and maintain a pattern especially when ending a QSO.

6. The DX station should create a rhythm or timing which maintains a good rate and allows the pile-up to call at the right time.

7. The operators in the pile-up, if not sure of a QSO, should dupe and the DX operator continue not wasting time commenting.

8. The DX station should work those who will create the fastest rate, at least at first, then make an effort to work the weaker stations.

9. No one should lecture on the air.

10. Everyone should always require and give full calls.

11. Know and practice the gray line.

12. Know the equipment being operated such as the split button, audio levels, keying wave form, etc.

13. NEVER be a "KC Cop"....never.

14. Operators giving spots on a DX Cluster should insure their accuracy!

15. Keep away from personal, political, and religious comment any time on the air and/or the DX Cluster. Keep all comments in the true spirit of ham radio whereby ALL ARE EQUAL.

16. Don't rush when giving your call when the DX station is standing by, especially on CW. Time will be lost trying to obtain ALL of the call sign.
17. Don't call the DX station constantly. Get in the rhythm.
18. Let the last station complete his QSO.
19. Use only the power it takes and figure out what that is!
20. Figure out the DX operator's operating practice for greater success.

Who did it?

The amateur-engineer-inventor was none other than good old Hiram Percy Maxim, himself. The Pope Company for which Maxim had worked had bought an 1877, all-inclusive and very cloudy patent that included engine, drive train and vehicle. Maxim thought the patent was worthless. A long patent battle was brought against Pope by a "grumpy little man" as Maxim described him. This battle finally resulted in the patent being discarded. Being a highly honest and open man, Maxim doubtlessly contributed to this ultimate decision through his testimony in the case. The "grumpy little man" was Henry Ford. *Flap over DXpedition to Libya*

Recently, an item appeared on the Internet that stated operators in the 5A7A DXpedition (Libya) refused to work Israeli amateurs. This item created a bit of a flap as might be expected. The actual situation is a little different than appeared in the Internet item. It is another example of the rancor between some Arab nations and Israel. The Libyan government issued a license for the 5A7A operation only on the condition the hams would not QSO Israelis. As disgusting as this is, there is nothing new about it. It also has not been solely an Arab-Israel issue. Over the years, countries other than Arabian have issued similar prohibitions for contacts with different of the world's countries. The practice, at least during later years, has mostly regarded Arab nations and Israel.

The choice that faced the German group that sponsored the 5A7A DXpedition was to accept the restriction against Israeli hams, or to cancel the operation. Apparently some members of the DXpedition chose not to go; others opted to go. Regardless, the prohibition against contacting Israeli amateurs came from the Lib-yan government, not from the hams. I will not get into a discussion of whether the DXpedition should have been held or been cancelled. This latter discussion is far beyond the realm of Amateur Radio. *Today's pun*

Once again, the ARRL Board of Directors has acted in support of the National Traffic System (NTS). Contrary to some NTS operators who believe ARRL is attempting to kill NTS, the Board unanimously approved the report of its National Emergency Response Preparedness Committee that endorsed NTS. The facts are that NTS can serve as a valuable source of training as well as of moving longer haul traffic during disasters. Equally obvious is that the character of NTS is changing and is likely to continue to change. It is not and increasingly will cease to be your grandfather's NTS.

BPL in Cass County, Michigan

ARLB009 Section Manager election results announced (February 21, 2007)

One new ARRL Section Manager has been elected, while 8 incumbent SMs have retained their seats. New terms for all successful candidates begin April 1.
