

#### ARDF Update: Trophies Await at USA's First Blind ARDF Championships

"I love the ham radio! It opens me to the world!" Those were the excited words of a patient in the rehabilitation unit of a hospital where my wife April WA6OPS, held weekly <u>Rehab Radio</u> sessions for over 15 years. To us, there is no doubt that the activities of our hobby can be especially stimulating and motivating to persons with physical limitations.

The therapeutic benefits of ham radio aren't limited to ham shacks. Outdoor sessions of Amateur Radio Direction Finding (ARDF) can also be a boon to the disabled. With some adaptive gear and an "extender", handicapped hams and non-hams have experienced on-foot radio foxhunting alongside the fully able at conventions and other events in southern California and at Handi-Ham Radio Camps. Foxhunting for the disabled will be taken to the next level when the First USA Blind ARDF Championships take place in Dayton, Ohio on the last day of Hamfest 2007. The welcome mat is out. No experience is necessary. Extenders will not be needed this time.

#### Croatia Leads the Way

Like formal ARDF for the sighted, ARDF for the blind is a European innovation. No country has more of it than Croatia, where the first such special foxhunts began in 1995 and have been well attended. The Louis Braille Radio Club for the Blind, part of the Blind Association in Zagreb, sponsors annual events complete with trophies and a banquet afterwards.

Rules and procedures for USA's first national ARDF event for the blind will be adopted from the Croatian's rules, which were originally written by Zeljko Ulip 9A2EY. There are some similarities to championship ARDF rules for the sighted, such as the frequency bands and the division of competitors into age/gender categories. Scoring is first by number of transmitters found and second by elapsed time.

A site for Croatian-style blind ARDF must be flat and open, perhaps a large lawn, with no obstacles such as holes or tree stumps. This frees the participants to walk or run as fast as they are able without fear of tripping over something hazardous. Sinclair Park in Dayton is ideal.

Standard ARDF under international rules has five unattended automatic "foxes" on a course of about 5 kilometers, with power up to 3 watts. Foxes transmit one at a time on the same frequency for 60 seconds each in rotating sequence. Competitors can find them in any order. Participants are started at five-minute intervals, at the moment #1 goes on the air. At the World Championships, there may be several hundred on the course at the same time.

By comparison, blind ARDF courses have three to five transmitters of about 100 milliwatts, with attendants. Course length is less than a half kilometer. Only one competitor is on the course at a time, attempting to find foxes one at a time in numbered order. As he or she leaves the starting point, #1 is on the air and it stays on until it is found. An official silently runs or walks alongside, speaking only to warn if the participant is about to go out of the competition boundary.

As soon as the runner steps inside the 5-meter circle of chalk or tape surrounding the antenna of fox #1, the official shouts "stop," the attendant at #1 turns it off and the attendant at #2 turns that one on. The competitor immediately takes off after #2 and so on, until timing is stopped when the last fox is found. Members of the OH-KY-IN Amateur Radio Club are sponsoring this pioneering event. Co-chairs of the organizing committee are Dick Arnett WB4SUV and Bob Frey WA6EZV, who also put on the USA ARDF Championships in 2003. Participants need not be licensed Amateur Radio operators, but they must be blind or sight-impaired. They must also be capable of walking or running without assistance. For fairness, those who are not totally blind will be asked to wear opaque goggles on the course.

This transmitter hunt will be on 80 meters in the CW segment. Participants are encouraged to bring their favorite on-foot RDF equipment for this range. For those who don't have any, there will be a variety of loaner sets to choose from, including a Ukrainian loop-antenna model and a German set with ferrite rod antenna. With either, it's easy to determine bearings by signal loudness in the headphones; no S-meter is needed. There will be a practice session to familiarize participants with the RDF gear before the competition begins.

The fun gets under way at 9 AM on Sunday, May 20, 2007, weather permitting, at Sinclair Park, which is about two miles southwest of the Hamvention headquarters at Hara Arena. After everyone has had a chance to test out the equipment he or she will use, the competition will begin.

More information on this event is at the OH-KY-IN ARDF Web site. The organizers want to get a good head count ahead of time for planning, so please visit this site, then register or contact them. Please pass the word to organizations for the blind in your area.

#### In Other News...

WB4SUV, WA6EZV and friends are also putting on the annual Hamvention Foxhunt Forum in Room 5 of Hara Arena at 1145 hours on Saturday. This 75-minute session always has a variety of speakers to present the newest equipment, techniques and event information about both on-foot and vehicular transmitter hunting. Take time out from the exhibit hall and flea market to attend.

As the weather warms up, it's time for your club to start planning for the outdoor foxhunting season. A good time for your first event would be the CQ Worldwide Foxhunting Weekend, May 12-13. Details are in my article, "Take the Foxhunting Challenge," in the April 2007 issue of *CQ Magazine*.

Encourage the best on-foot foxhunters in your club to set aside the weekend of September 14 - 16 for USA's national Championships of ARDF, combined with the biennial ARDF Championships of IARU Region 2 (North and South America). This year's site is in the forests near Lake Tahoe on the California-Nevada border. Watch for details in an ARDF Update when registration opens. Meanwhile, you can read about past and future USA Championships and many other ARDF topics at my "Homing In" Web site.

#### ARLB012 FCC poised to lower vanity call sign fee

The FCC has proposed reducing the regulatory fee to obtain or retain an Amateur Radio vanity call sign by more than 40 percent starting later this year. In a Notice of Proposed Rule Making (NPRM) released April 18, "Assessment and Collection of Regulatory Fees for Fiscal Year 2007," in MD Docket 07-81, the Commission is proposing to cut the fee from its current \$20.80 to \$11.70. If ultimately adopted, that would mark the lowest fee in the history of the current vanity call sign program. The FCC proposed to collect nearly \$290.3 million in FY 2007 regulatory fees.

"These fees are mandated by Congress and are collected to recover the regulatory costs associated with the Commission's enforcement, policy and rulemaking, user information, and international activities," the FCC said. "Consistent with our established practice, we intend to collect these regulatory fees in the August-September 2007 time frame in order to collect the required amount by the end of the fiscal year." Comments on MD Docket 07-81 are due May 3. Reply comments are due May 11.

The vanity call sign fee has fluctuated over the 11 years of the current vanity call sign program, from a low of \$12 to a high of \$50. The FCC says it anticipates some 14,700 Amateur Radio vanity call sign "payment units" or applications during the next fiscal year.

The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign but upon renewing a vanity call sign for a new term. The first vanity call sign licenses issued under the current Amateur Radio vanity call sign program that began in 1996 came up for renewal last year.

Those holding vanity call signs issued prior to 1996 are exempt from having to pay the vanity call sign regulatory fee at renewal, however. That's because Congress did not authorize the FCC to collect regulatory fees until 1993. Such "heritage" vanity call sign holders do not appear as vanity licensees in the FCC Amateur Radio database.

Amateur Radio licensees may file for renewal only within 90 days of their license expiration date. All radio amateurs must have an FCC Registration Number (FRN) before filing any application with the Commission. ### Weaver's words: Hamvention<sup>R</sup>'s coming with 8<snips == HR 462 ==

In January, Arkansas US Rep Mike Ross, WD5DVR introduced the Emergency Amateur Radio Interference Protection Act of 2007 into the House. This bill has been referred to the House Committee on Energy and Commerce. If enacted into law, the bill will require the FCC to conduct a comprehensive study on BPL. The bill is intended to lead to improved rules to prevent interference from BPL and similar devices. So should everyone rush to send letters to their US Representative and Senators? The answer to this is a clear "No; definitely no." Now is not the time to do this.

The most logical sequence of activities we can expect to take on this bill will begin at the top of the ARRL Legislative Action Program when the Directors and Division Legislative Action Chairs receive the "go" signal from HQ.

This "go" signal is likely to request Legislative Action Assistants (LAAs) who are assigned to members of the House Committee on Energy and Commerce to call on these Representatives or their aides in their home offices. These visits will promote favorable action by the Committee. Depending on the precise manner in which things develop, the next step is likely to be to ask all LAAs to call on the local offices of each Representative. Finally, every member will probably be asked to write their Representative to encourage them to vote for the bill.

One major risk exists if we jump the gun in our zeal to get this bill passed. This is that we can inadvertently ruin the chances of its passage. Effective lobbying requires that we work in a coordinated manner. Lack

of coordination can prove disruptive to the effort and cause us to throw away our chances of a legislative victory.

#### == IT'S MY TURN =

I'm going to gripe. What about? Single-purpose members, this is what. You know, the kind of folks who refuse to take ice cream unless they can have chocolate and chocolate, only, even if the refrigerator is crammed full with nothing but vanilla, strawberry, butter pecan, black cherry, butterscotch and peppermint. Each member of the Board of Directors, including me, receives complaints and requests for change. This is a good thing. Frankly, I want to hear when there are things that need to be improved and changed in ARRL as well as in government regulatory arenas. So, what is it that disturbs me?

I'm disturbed by members who complain about a single aspect of all of the services provided by ARRL and threaten to drop their membership if this one, single thing is not changed. This attitude strikes me as being like a little boy who demands the rules of the pick-up baseball game be changed to meet his wishes. "Give me 5 strikes or I won't play and I'll take my ball and go home so you can't play, either," he demands.

Please hold tight and take no action until the right time comes and you are asked to take action. Be part of the team. Your help is needed and it will be requested . . . at the right time.

I'm sure I've already made a few folks unhappy, but please understand I am not referring to members who complain or ask about situations and keep everything in perspective. But, stop and think about it a little. With 150,000 ARRL members, what are the chances that every one of these will agree with everything ARRL does? If you have any concept of human nature, you know the chances are high that well less than a 2/3 majority will agree with everything. This means that few people, including me, are totally satisfied with everything we do.

Think about it even a little more. Suppose you are a DXer as I am. Even though we DXers often seem to act like we are the only people in ham radio, we represent a minority of amateurs. Why should we expect the ARRL Board to kowtow to our needs to the exclusion of everyone else? We shouldn't.

Or, suppose you are a CW op, as I am. We are in the minority here, also. It would be unrealistic for us to think Amateur Radio should be run as though we are the sole reason it still exists. We aren't.

What about SSBers and FMers? I don't have the figures, but let's suppose one of these groups represents the majority of hams. Should even slightly over 51% of amateurs expect to run the show for all others? I don't think so.

Data operators? NTSers? ATVers? Name still more special interest groups, and they are most likely in the minority. Come to think of it (some of you better sit down and hold on for this one), not one of us are the sole reason Amateur Radio exists!

Taking a different view, suppose you are a contester or whatever you wish to name, and ARRL has a rule for contesting that you don't like. Some folks have said, "This rule is stupid. Unless you change it right away, you don't represent my interests. Change it or I won't renew my membership when it comes due!" The fact is that ARRL first and foremost primarily exists to promote the good of all of Amateur Radio -- not just some small niche of interest. As much fun as each of the many aspects of Amateur Radio is, no single one is the sole reason ARRL exists.

My hope is that even when a member becomes aggravated, he or she put things into perspective. Become aggravated; certainly. I do, but please remember that ARRL is attempting to help thousands of people fulfill their Amateur Radio dreams in scores of different specialty interest groups. It is important that we all, individually and collectively, respect the legitimate differences we pursue in hamming as well as the fact that not every aspect of our many favorite operating niches must coexist within a relatively confined electronic space.

Be an individual . . . fight for your individuality . . . but do this in a dignified, courteous manner knowing we cannot all have everything we want.
