# Garbage Bag as EmComm Asset

The garbage bag is the most overlooked yet most practical single item available in an emergency. Not only can it protect you and/or your equipment from a variety of climatic conditions, it facilitates carrying items ranging from your most expensive equipment to trash from an abandoned site.

Further, the typical garbage bag weighs less than an ounce, occupies little more room than a business envelope and costs pennies. From personal experience in the most inclement weather and most demanding situations, where I didn't have a garbage bag, I wished I had one, and, where I gave thanks for having had the prescience to have brought one along. In an emergency, after functioning communications equipment, nothing beats a garbage bag!

I work with a great staff of Assistant Section Managers and ARRL Field Organization leaders in the Ohio Section to make sure all of our programs are running in top order. Every question and concern from

Amateur Radio operators is given consideration and attention by me and my staff. Please allow me to continue the work I have started for YOU, by electing me for another 2-year term as YOUR ARRL SECTION MANAGER!

# About Me ..

I was born at the young age of zero in Lancaster, Ohio. I attended school in the Lancaster city school systems, and graduated from Lancaster High in 1981. During my school years, I was active in the Audio-Visual departments of the school libraries (is that surprising to you?), where I could thread a 16mm projector like no one's business (if you don't know what a 16mm projector is ... just nod your head and keep reading ...) I majored in Drafting and Design technology at the local vocational school. I was hooked, and found my other true love, computer programming. Moving forward, I work for Diamond Power International, located in Lancaster. I have worked as a Draftsman, Designer (Mechanical and Electrical), Drafting Department Supervisor, and currently the Systems Programmer and CAD (Computer Aided Drafting) System Administrator. My Amateur Radio career started in 1995 when I finally got the Ham Radio fever after attending Dayton Hamvention<sup>®</sup> for many years prior (before interested in radios, I was buying computer parts). I earned my Technician license in May of 1995, and was granted the call sign of KB8ZUF. In the next 4 years I earned my Tech Plus, General, Advanced (and was granted the upgrade call of KI8GW), and finally earned Amateur Extra Class in June of 1999, after passing my 20-word per minute Morse Code exam in Lancaster, Ohio.

I became interested in Public Service communications when I was invited to help with the Columbus Marathon in late 1995. Since that event I became very active with the Central Ohio Amateur Radio Emergency Service, becoming an Assistant Emergency Coordinator for Franklin County, and was then appointed Emergency Coordinator in 2002. During those years I was mentored by Bill Carpenter AA8EY, who taught me leadership and how to motivate volunteers. I held positions of Newsletter Editor, Public Service Events Coordinator (organizing over 80 public service events per year for the group) and Net Manager.

In Winter of 2003, I was appointed District Emergency Coordinator, overseeing Ohio ARES<sup>R</sup> District 7 (10 counties in Central Ohio), and in 2006 I was appointed Section Emergency Coordinator for the entire state of Ohio. I retired in August 2008, and then called "back into duty" as Section Manager in July of 2009, to fulfill the remainder of term left vacant by the death of then Section Manager Joe Phillips K8QOE the month prior.

I live in Pickerington, Ohio (Fairfield County) with my Wife of 23 years, Jackie (who is licensed as KC8ESO), and our 10 year-old Daughter, Hanna (who is still not sure about all this radio stuff).

My other activities are Church (Lector, Extraordinary Minister of Holy Communion, and Pastoral Council for Seton Parish in Pickerington), Knight of Columbus (Past Grand Knight, Council 11187, and Fourth Degree Sir Knight, Assembly 2900), and am also a First Degree Black Belt in Okinawan Shuri-Ryu Karate, having competed for many years from 1982 to 1994. I trained under Roger Monk of Logan, Bill Smith of Newark, and Woodrow Fairbanks of Cincinnati.

#### The Road Ahead ...

The question I have been getting, while making visits to clubs, is "Where do you see taking the Ohio Section in the next two years as Section Manager, if you win the election?"

Talk about one tough question. To help answer this, I ask that you come with me, and take a look at the last ten years in Amateur Radio (Feel free to imagine one of those "Scooby-Doo" wavy flashback effects here..)

Ten years ago at this time, we began seeing some of the most dramatic changes in Amateur Radio licensing. The FCC reduced the number of Amateur Radio license classes from five (Novice, Technician, General, Advanced, and Amateur Extra) to only three (our current classes of Technician, General and Amateur Extra), and began the elimination of Morse Code proficiency testing. For the first time, we started seeing people joining the ranks of Amateur Radio operators, *The Q Fivez, Oh Ky In ARS, June 2010 page 8* 

due to the elimination of licensing "hurdles". We then found it more important to mentor these new Hams after they received their operating license, than before they took their tests.

Then our country got a 1-2 punch in the gut in a few short years with September 11<sup>th</sup>, 2001, and Hurricane Katrina. Our entire focus of Amateur Radio operators drastically changed from routine public service to learning about FEMA standards, Incident Command Systems, EMA procedures, etc. We were being involved in state and local government meetings as the communication resource that would be available "when all else fails". At this time, even more people were obtaining their Amateur Radio licenses, to be prepared in the event of natural and man-made disasters, as well as providing the public with the security of dependable auxiliary communications for their communities.

As these people join our ranks, we MUST be there for them, with open arms, clubs, and Emergency Communication groups, be it ARES, MARS, SATERN, SKYWARN or RACES, to take these people and share our knowledge and experience. Without continuing to build our foundations of people and skills, our beloved hobby will surely suffer, and our effectiveness as being the communications "when all else fails" will be reflected as well.

Clubs are the basic bricks in our foundation, be it either the club with hundreds of members, or the small town group who meets as the public library. I see clubs receiving support from an expanded Ohio Section Cabinet, with people whose leadership and skills will be valuable aid in helping clubs be those mentors for our upcoming Amateur Radio operators, who at this time are not even aware of the adventure they are about to begin.

#### ARLB016 FCC Seeks Comments on Newly Proposed Rules posted May 19

In March, the FCC released a Notice of Proposed Rulemaking (NPRM) that proposed to amend Part 97 to facilitate the use of spread spectrum communications technologies by eliminating the requirement that amateur stations use automatic power control (APC) to reduce transmitter power when the station transmits a spread spectrum (SS) emission, and reducing the maximum transmitter power output when transmitting a SS emission (WT Docket No 10-62). On May 14, a summary of the NPRM and the Order was published in the *Federal Register*; the FCC is seeking comments on the NPRM. Comments must be filed on or before June 14, 2010 (30 days after publication in the *Federal Register*); reply comments must be filed on or before June 28, 2010 (45 days after publication in the *Federal Register*).

Instructions on how to file comments are listed beginning on page 5 of the NPRM, available on the web at, *http://hraunfoss.fcc.gov/edocs\_public/attachmatch/FCC-10-38A1.pdf*.

The Commission also attached an Order to the NPRM that makes certain non-substantive revisions to Part 97. According to the FCC, the rules are necessary to amend the Amateur Service rules or conform them to prior Commission decisions, enhancing the usefulness of the Amateur Service rules by making them conform with other Commission rules, thereby eliminating licensee confusion when applying the rules to Amateur Service operations. The new rules will take effect July 13, 2010.





ARLB017 NCVEC Ouestion Pool Committee Withdraws Four Ouestions (posted May 25) The Question Pool Committee (QPC) of the National Conference of Volunteer Examiner Coordinators (NCVEC) announced the withdrawal of two questions from the Technician class pool and two questions from the Extra class pool.

Volunteer Examiner Coordinators (VECs) and Volunteer Examiners (VEs) must take action to remove these questions from use by July 1, 2010. Due to a rules change and pending action by the FCC, questions T2C02 and T2C03 from the July 2010 Technician Pool and questions E1C04 and E1C05 from the July 2008 Extra Pool may not be used in examinations after June 30.

The two Technician questions dealt with emergency communications and Section 97.113 of the FCC's rules governing Amateur Radio. In March, the Commission released a Notice of Proposed Rule Making (NPRM), WP Docket No 10-72, that proposes to amend the rules to provide that, under certain limited conditions, Amateur Radio operators may transmit messages during emergency and disaster preparedness The Q Fivez, Oh Ky In ARS, June 2010 page 13 drills, regardless of whether the operators are employees of entities participating in the drill.

"Adoption of the NPRM appears more likely than not, abolishing the temporary waiver [needed for government-sponsored emergency communication drills] (T2C02) and making T2C03 an invalid question," the QPC said in a statement appearing on the NCVEC Web site. "Therefore, we feel it is best to withdraw these two questions now to avoid the possible inclusion of invalid information in training material now being prepared."

The two Extra questions dealt with third party restrictions as defined in 97.109(e); the FCC has since deleted this rule, so the information is no longer applicable to the Amateur Service.

#### **Ohio Senate Bill 218 Passes On Ohio Senate Floor**

Yesterday (posted May 14), during the May 12<sup>th</sup> session of the Ohio Senate, Ohio Senate Bill 218 (aka "PRB-1 for Ohio") passed by unanimous vote, and will move on for consideration in the Ohio House of Representatives.

This bill, which will require local municipalities to provide reasonable accommodations for Amateur Radio antennae, passed the Senate with a 32-0 vote for passage.

The next step is for the bill to be entered into the House of Representatives, combined with existing House Bill 212 in the Public Safety and Homeland Security Committee, and voted upon before being sent to the Governor for signing into law. The bill will be entered into the House within the next 2 weeks.

State Government Liaison Nick Pittner K8NAP said this is a great day for Amateur Radio in Ohio, and good news to have right before the Dayton Hamvention<sup>R</sup>!

Go to *www.ohiosenate.gov*, click on "Video Archive", "Session", "Session Video", and click the flash video for May 12<sup>th</sup> . Senate Bill 218 begins at the 35 minute mark. The testimony given by Senators Tim Schaffer and Tom Sawyer will mike you proud to be a Ham Radio operator.
