ARLB014 Senate "Companion" Bill to HR 607 Avoids Impacting Amateur Spectrum

On Thursday, May 19, Senators Joe Lieberman (ID-CT) and John McCain (R-AZ) introduced S 1040 -- The Broadband for First Responders Act of 2011 -- in the Senate. While it has a similar objective to HR 607 -- introduced in February by Representative Peter King (R-NY-3) -- this Senate bill, unlike HR 607,

does not call for auctioning any portions of Amateur Radio spectrum. Both bills call for the allocation of the so-called "D block" of spectrum, 758-763 and 788-793 MHz, to facilitate the development of a public safety broadband network. On learning in February that a Senate version of HR 607 was being drafted, ARRL Chief Executive Officer David Sumner K1ZZ met with staff members of the Senate's Homeland Security and Governmental Affairs Committee who were working on the bill to share the ARRL's concerns with regard to HR 607. "They seemed very receptive to our argument and appreciative of the public service contributions of radio amateurs," Sumner said. "It is gratifying to see that S 1040 avoids impacting our spectrum allocations."

Sumner explained that while some media reports are referring to S 1040 as "the Senate version of HR 607,"



Neither Mapquest's (too vague) nor Google's (too small) was of any particular help. Best bet to get to Mitchell Memorial Forest is to set your GPS if you have one for either Mitchell Memorial Forest or 5401 Zion Rd, Cleves. (Try before setting out to see what you get.) Alternatively, talk-in:

From Cheviot, take Bridgetown Rd SR 264 WEST to Taylor Rd (just west of Ebenezer Rd, bear right). Carry on to Wesselman Rd, turn left. Proceed on Wesselman to Zion Hill Rd, turn left. Proceed on Zion Hill to Zion Rd, turn right. Watch for Mitchell Memorial on your left, turn into park.

Hamilton Co season pass is now \$10 (recommended), day pass \$3 each. One or the other is required. Passes may be bought at park visitor ctrs, golf courses, Ranger stations or on line at http://www.greatparks.org (takes you to Hamilton Co Parks website)

It is important that radio amateurs not oppose S 1040: "There is no reason for us to do so. We support the creation of an interoperable broadband network for first responders. Other than to oppose any method that would impact amateur spectrum use, we do not support one method over another of achieving that objective. We only oppose one aspect of HR 607, not the entire bill."

S 1040 has been referred to the Senate Committee on Science, Commerce, and Transportation, chaired by Senator Jay Rockefeller (D-WV). Senator Rockefeller earlier introduced his own bill, S 28, to address the same general topic. Neither Senate bill would impact amateur spectrum.

ARLB013 FCC Seeks to Raise the Fee for Vanity Call Signs

The FCC released a Notice of Proposed Rulemaking and Order (NPRM) on May 3, seeking to raise the fee for Amateur Radio vanity call signs. Currently, a vanity call sign costs \$13.30 and is good for 10 years. The new fee, if the FCC plan goes through, will go up to \$14.20 for 10 years, an increase of 90 cents. The FCC

is authorized by the Communications Act of 1934 (as amended) to collect vanity call sign fees to recover the costs associated with that program.

The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign, but also upon renewing a vanity call sign for a new term. Instructions on how to comment on this NPRM are available on the FCC Web site at, http://www.fcc.gov/cgb/consumerfacts/howtocomment.html.

The vanity call sign fee has fluctuated over the 14 years of the current program -- from a low of \$11.70 in 2007 to a high of \$70 (as first proposed in the FCC's 1994 Report and Order). In 2007, the Commission lowered the fee from \$20.80 to \$11.70. The FCC said it anticipates some 14,600 Amateur Radio vanity call sign "payment units" or applications during the next fiscal year.

The vanity call sign regulatory fee is payable not only when applying for a new vanity call sign, but also upon renewing a vanity call sign for a new term. The first vanity call sign licenses issued under the current Amateur Radio vanity call sign program that began in 1996 came up for renewal five years ago.

Those holding vanity call signs issued prior to 1996 are exempt from having to pay the vanity call sign reg-ulatory fee at renewal, however. That's because Congress did not authorize the FCC to collect regulatory fees until 1993. Such "heritage" vanity call sign holders do not appear as vanity licensees in the FCC Ama-teur Radio database.

Amateur Radio licensees may file for renewal only within 90 days of their license expiration date. All radio amateurs must have an FCC Registration Number (FRN) before filing any application with the Commis-sion. Applicants can obtain an FRN by going to the ULS at, http://wireless.fcc.gov/uls/index.htm?job=home http://wireless.fcc.gov/uls/index.htm?job=home, and clicking on the "New Users Register" link. You must supply your Social Security Number to obtain an FRN.

State House Happenings – Nick Pittner K8NAP – Ohio State Government Liaison

H.B. 158 is the version of the amateur radio antenna bill now pending in the Ohio House of Representatives (as of May 18). It is assigned to the Local Government Committee for hearing and has now had three hearings in that committee. The first hearing was dedicated to presentation of the Bill by its primary

sponsors, Reps. Stebelton and Okey. Both representatives testified in favor of the Bill at its first hearing, April 12, and very effectively described what the Bill does and why it is necessary. The second hearing was scheduled for May 3 for the proponents of the Bill. The section legislative team was represented by Section Manager Frank Piper K18GW, Bill Carpenter AA8EY, John Tipka W8UL and Nick Pittner K8NAP. Rick Swain KK8O testified in writing but was not able to be present at the hearing that day. We also presented a short video clip of AA8EY handling emergency traffic during Hurricane Katrina.

The committee members asked a lot of questions about antennas, some of which were germane to the bill and some not. The provision establishing 75' as a presumed reasonable height for an antenna structure drew the most interest and a number of the members seemed to favor the general purpose of the Bill, but did not favor the numeric height provision as presented.

After the hearing we had a number of conversations with the sponsors that resulted in an amendment that was offered to and approved by the committee at its third meeting on May 10. 8<snip

Representatives Stebelton and Okey both favored the retention of the 75' provision in the bill (though the version that we offered would have deleted the numeric provision) and offered the amendment quoted above

The third hearing also saw the first opponent testimony that we have seen in any of the legislative sessions thus far. The Ohio Municipal League, through Columbus Attorney Steve Smith, testified in opposition to the bill at the third hearing. The Municipal League offered two objections: first, that the bill was unnecessary in light of PRB-1 and the second that it violated Ohio's constitutional Home Rule provision. His testimony was offered before the amendment discussed above was offered and in response to questions from the committee seemed to indicate that he would be satisfied with the amended language. He later retreated somewhat from that position, as he had not had any time to study the amendment. Rick Swain, Nick Pittner and Capital Law School Professor Jeff Ferriell K8ZDA were present for the Section legislative team and Professor Ferriell offered brief testimony on the fact that PRB-1, having the force and effect of federal law, supersedes the Ohio Constitution as well as acts of the Ohio Legislature.

My personal view is that the Municipal League's position should be ignored for two reasons. First, 27 states have recognized that the need for amateur antennas is sufficiently important to be carried into state law, and that need is no less in Ohio today than in any of those other states. Thus, the League's "re-dundancy" argument lacks merit. Second, and though I am by no means an expert on the Home Rule provisions of the Ohio Constitution, it seems that the League's objection to this Bill appears to be based more on policy concerns than anything else. They seem to be saying that they would oppose any legislative provision that purported to limit the authority of local governments in Ohio, regardless of the subject matter of the Bill. The bottom line is that even the Ohio Constitution does not trump federal law, and municipalities in Ohio are obliged to comply with PRB-1, regardless of whether H.B. 158 passes or not. To the extent that H.B. 158 simply clarifies and explains that which already a binding obligation on the municipalities it could well be argued that they are better off with the Bill than without it. However, since the committee hearings do not lend themselves to a debate forum, we will have to wait and see if there is a chance to provide a thorough response to the League's position. As of this time no additional hearings have been scheduled for H.B. 158 and we await further information from the Committee leadership on what the next action will be.

S.B. 93 is the version of the antenna bill pending in the Ohio Senate. At this point there have been no committee hearings


Imogene Steely Coffey, 81, died at Hospice of Cincinnati at Blue Ash on May 11, 2011.
