

# Anyone want to get started using digital voice on HF?

>From the AMSAT news service bulletin: FreeDV Ham Radio Digital Voice Software

FreeDV is an application for Windows and Linux that allows any HF SSB radio to be used for digital voice mode with bandwidth of just 1.1 kHz. Speech is compressed down to 1400 bit/s then modulated onto a 1100 Hz wide QPSK signal which is sent to the Mic input of a SSB radio. On receive, the signal is received by the SSB radio, then demodulated and decoded by FreeDV.

Features:

- + Codec 2 voice coder and FDMDV modem
- + 50 baud 14 QPSK voice data

- + 1 Center BPSK carrier with 2x power for fast and robust synchronization.
- + 1.125 kHz spectrum bandwidth (half SSB) with 75 Hz carrier spacing
- + 1400 bit/s data rate with 1375 bit/s open source Codec 2 voice coding and 25 bit/s text for call sign ID
- + No interleaving in time or FEC philosophy resulting in low latency, fast synchronization and quick recovery from fades.
- + 44.1 or 48kHz sample rate sound card compatible

FreeDV, the new HF digital audio program for Radio Amateurs:

Watch when it's switched to analog SSB. The SSB bandwidth is about 3 times that of the digital audio. Also note the diagonal black streaks across the waterfall display. That's fading, probably from two reflections arriving out of phase. The ID on the bottom is coming in during the silent periods between words.

This software is Open Source, and uses Codec2. This Codec was presented by Bruce Robertson VE9QRP at the 2012 AMSAT Space Symposium in Orlando FL.

#### **IARU Welcomes Two New Member Societies**

Earlier this year, the International Amateur Radio Union (IARU) notified its Member Societies that two new national Amateur Radio organizations wished to join the IARU and would need to be voted in: the Federation of Radio Sport of Azerbaijan (FRSA) and the St Vincent and the Grenadines Amateur Radio Club (SVGARC). Ballots from all the Member Societies that responded were counted on November 1.

Based in Baku, Azerbaijan, the FRSA was formally organized on December 30, 2001. There are 50 licensed members of the FRSA out of a total amateur population of approximately 50 in Azerbaijan. The SVGARC is based in St Vincent, St Vincent and the Grenadines and was formally organized in 1951. There are 21 licensed members of the SVGARC, out of a total amateur population of approximately 134 in the country. Both organizations have confirmed to the IARU that they have the ability to meet financial obligations as a member of the IARU, are legally able to act in the furtherance of IARU objectives within their respective countries and will adhere to the Constitutions of both the IARU and its respective Regional Organization.

In order for a new national organization to gain IARU membership, there must be 53 affirmative votes from current IARU Member Societies. The Federation of Radio Sport of Azerbaijan received 60 affirmative votes and the St Vincent and the Grenadines Amateur Radio Club received 61. All Member Societies

that voted did so in favor of admitting these national organizations to the IARU. There are now more than 160 IARU Member Societies. *ARRL Letter* 12-13-12

# Notes from the Section Traffic Manager – Is this the end of Ham Radio?

Over the last few months I have received several "end of the world" emails. The one claim is that the world will end on December 21<sup>st</sup> as this is the day one of the three Mayan calendars ends. This end of the world prediction has been around for a number of years. Will this also be the end of ham radio? I just can't seem to believe this rumor as it does not seem logical to me that the Mayans knew when the world would come to an end, but I could be wrong. One event station will "celebrate" this literally as a once in a lifetime event. Special Event Station N0D (that's November Zero Delta or Now Zero Days as they put it) will be active for three days during and possibly after the end

of the world. They state that they will be on the air as long as possible for the three days and that December 22<sup>nd</sup> is a little iffy right now. Their website <a href="http://www.nowzerodays.com/index.html">http://www.nowzerodays.com/index.html</a> (was still up as Ye Ed pasted up) does not give any specific frequency that they will be on but does show the proposed QSL card available for an SASE to the address in QRZ. This might be worth checking out if this goes to print before then. If this goes to print after

December 21<sup>st</sup> and you are reading this, than we can pretty well have this myth debunked.

The Special Event Station website claims that "Amateur radio stations around the crumbling globe are invited to contact N0D, which will be operating from a secret undisclosed location. If Doomsday actually does happen, they regret that sending a QSL will not be possible so hold on to your SASE until the 22<sup>nd</sup> at least. You can celebrate Doomsday by contacting N0D directly on the air. Amateurs can also become an official Doomsday station by registering on their website. You will be given a registration number and the authority to identify yourself as an Official Doomsday Station followed by your Doomsday number."

The other "end of the world as we know it event" rumor has a similar time frame. This rumored event is that their will be a mega-solar storm that will be so strong that it will put out pulses called EMP pulses (Electro-Magnetic-Pulse). An Electro-Magnetic-Pulse is a sudden burst of radiation that produces a damaging voltage surge. EMPs can come from a nuclear detonation high in our atmosphere or even from our own Sun! These pulses are supposed to be so strong as to fry the electrical grid and anything that is electronic.

It's alarming to think about but an EMP could disrupt everything. In a flash, electronics in everything we use in life would stop working. **Snip8**<

Many believe an EMP attack is the number one threat to the American infrastructure and way of life. Even our personal safety would be compromised. If there are droves of people without anything, all hell could break lose. Imagine what the highways would look like when millions of cars and trucks came to an instant and permanent stop. Many families would be separated with no way to get home. For most people, there would be no communications or method of getting accurate news updates. You will not know where your family and loved ones are and have no way of contacting them. Snip8<

Do these rumors have any merit? Well I don't know if any of this is possible or if these dates are just made up. But all is not lost because even NASA has taken notice of these threats and has plenty to say.

According to NASA, it won't happen. NASA's Jet Propulsion Laboratory has just put out a new video, *Just Another Day, (found by Ye Ed)* to address some of the rumors going around about the Mayan Apocalypse. According to NASA, 2012 Doomsday is just a myth. Don Yeomans, head of the Near-Earth Objects Program Office at NASA/JPL, addresses many apocalyptic rumors in this new video. For one, he states that the Mayan calendar doesn't actually end in December 2012.

According to Yeomans, the Mayans calendar functions just like ours. Our calendar ends in December but starts again in January. Yeomans said: "(The Mayan calendar) does not end on December 21, 2012; it's just the end of the cycle and the beginning of a new one. It's just like on December 31, our calendar comes to an end, but a new calendar begins on January 1."

Yeomans also said that the planet Nibiru, which is rumored to be on a crash course with earth, doesn't exist. Yeomans said: "This enormous planet is supposed to be coming toward Earth, but if it were, we would have seen it long ago. And if it were invisible somehow, we would have seen the [gravitational] effects of this planet on neighboring planets. Thousands of astronomers who scan the sky on a daily basis have not seen this." But what about a giant cover-up by NASA? Prosperous, says Yeomans.

"Can you imagine thousands of astronomers who observe the skies on a daily basis keeping the same secret from the public for several years?"

Yeomans also addresses the issue of solar flares (the earth's magnetosphere shields us from radiation), planetary alignments that could cause massive tidal waves (there are no planetary alignments in December of 2012), and a shift in the earth's axis (can't happen because the moon stabilizes the earth).

Yeomans said: "Extraordinary claims require extraordinary evidence.

Since the beginning of time there have been literally hundreds of thousands of predictions for the end of the world, and we're still here." Find more from NASA here:

# Statehouse happenings – A Christmas present for Ohio hams

Okay, so H.B. 158 wasn't exactly delivered on Dec. 25, but it does represent a large benefit for Ohio amateurs and marks the culmination of nearly five years of legislative effort. H.B. 158 is Ohio's antenna bill, giving radio amateur antenna requests a strong preference in local zoning decisions. While it doesn't solve all of our problems, such as deed restrictions or neighborhood and condo agreements, it goes a long way toward helping those who would otherwise be limited by city, county or township zoning ordinances.

The Bill became law in Ohio on August 15 and with it Ohio joins 26 other states that have passed state laws similar to the FCC regulations designated as PRB-1, regulations which prohibit state and local governments from imposing unreasonable limitations on amateur antennas.

Of course our legislative Santa had some help in this effort and now is a good time to once again thank the "elves" who helped make Ohio's antenna law a reality. First on the list, of course is the "chief elf", our Section Manager Frank Piper KI8GW. Frank was there whenever needed – and he was needed a lot, both as a legislative witness and an advisor. Right behind Frank was Terri Kovalchik N8TLK whose research and organizational skills made the effort possible. In addition to attending hearings and keeping us organized, Terri did a review and summary of existing legislation in every state that had passed "PRB-1 like" legislation that provided impressive background information for our legislative sponsors.

In addition to Frank and Terri, our effort was supported with an impressive array of amateur radio background and experience as evidenced by our legislative witnesses who gave their personal time and effort to help oftenconfused legislative committee members understand why radio transmissions require antennas. That group of dedicated "elves" included Rick Swain KK8O (also, often called upon for help), Bill Carpenter AA8EY, Steve Katz N8WL, Don Kovalchik W8DPK, Dr. Bob Lewis N8GU, and John Tipka W8UL. A special thanks also goes to Capital University law professor Jeff Ferriell K8ZDA for his help in addressing the Home Rule issues that seemed to trouble some of the legislators. Numerous others, too many in numbers to list here, also helped with guidance, suggestions, calls and emails. Thanks to all of you. You efforts have made Ohio a better place to be a radio amateur and a safer place for all Ohioans in times of emergency.

As we would with any new piece of radio gear, it's time to take our legislative present out of the box (read the instructions later, if ever) and give it a try. Some Ohio hams have already seen the benefits of the new legislation as their antenna applications received swift approval. Others may still be pending. So, how can we best use our newfound antenna authority? Obviously, putting up antennas is a good place to begin. But, what about helping our local radio clubs become true resource centers for new hams? Getting new hams on the air is essential to the continued life of our hobby, and antennas are an essential part of that equation. Or, should we use our success to try to springboard other ham-friendly legislation in Ohio, or perhaps try to help other states with their own antenna bills? The possibilities are endless and as the New Year approaches it's certainly time to consider some of those options and plan for our efforts next year.

# Affiliated club news

As we close out 2012 we currently have 95 clubs that are considered active in Ohio. An active club is an ARRL affiliated club who has filed an annual report sometime in the past four years. The national club database indicates that there are 101 inactive clubs (clubs not filing an annual report for 5 or more years). Many of these no longer exist, but when reviewing this list some clubs appear in both active and inactive lists and in some instances are on the inactive list due to club consolidations or club name changes. I do contact the contact people in these clubs on occasion to see if I get a response. I seldom do.

Of the 95 clubs that are considered active, 25 have updated their annual reports in the past two years and another 44 have files an annual report since Dec 2011. Ohio boasts 16 clubs with current up to date Special Service status and two more whose SSC status expired in 2012 that I am hopeful will reapply. SSC terms are limited and need to be renewed every two years. Thirteen of the current SSC clubs will need to reapply in 2013 to stay current. (Apply sooner than later!) How do we compare with other the other Great Lake District Sections?

Michigan currently shows 84 active ARRL Affiliated clubs with 37 of those filing annual reports in the past year. Michigan has 9 Special Service Clubs. Kentucky shows 32 ARRL Affiliated active clubs with 16 filing an annual report in the past year and has no current Special Service Clubs.

What about club membership? The average club membership is 59 people per club. The average ARRL membership of members in clubs is 41 members per club. The median club membership is 41. The median ARRL membership is only 29. This is an area we can improve. The active club listing the most members on its annual report is The Greater Cincinnati ARA who lists 455 members. The smallest club is the Stark DX Assn. who boasts 4 members. (Note that the Dayton ARA has not filed and annual report since 2006 when they listed 700 members.)

The total club membership for the Ohio Section includes 5,434 of which 3,759 are ARRL members. However, these figures may be a bit inflated due to the fact that many people belong to more than one club.

Within the annual report, clubs are asked what activities their club judges as their Specialties. The following stats indicate what Ohio's clubs' specialties are.

Does anyone see an area where should be finding ways to improve our expertise? Another question presented on the annual report is what services does a club offer?

For the Ohio Section 75 clubs publish a newsletter, 74 maintain a repeater or repeaters, 67 offer Technician Class lessons or classes, 67 also offer exam sessions to acquire a license, 51 clubs have a mentor or Elmer program, 48 clubs offer General Class or higher lessons or classes, 37 transmit some sort of on-the-air bulletin, 28 clubs have a Hamfest, 25 clubs maintain a Packet Radio BBS and 17 clubs have a TVI/RFI committee. 83 clubs also list a URL for a club website.

Ohio has a long, storied and interesting history when it comes to its clubs. 29 of our clubs have exceeded 50 years of affiliation with the ARRL another 31 have celebrated 25 years of ARRL affiliation. Our oldest two affiliates are Mahoning Valley ARA who affiliated on 2/6/1925 and the Findlay Radio Club who affiliated 6/4/1925. But they may not be the oldest clubs in Ohio, as the Cambridge ARA who didn't file for affiliation until 1947 was charted in 1913!

They celebrate their 100<sup>th</sup> anniversary as a club this coming year. I understand that the Mahoning Valley group wasn't too far behind them when forming. Our newest affiliates are the Central Ohio Radio Club who affiliated 7/27/2011 preceded by the Butler County ARA who affiliated 4/27/2011.

It has been a fantastic experience traveling around Ohio the past two years visiting club meetings, Hamfests, field days and special events.

Our clubs and our members are doing a great job of promoting Amateur Radio. They are active in their communities. They also have fun doing what they do. I am very proud of all they do and all the service they offer our communities. Let's make next year even better.

At the present moment, if you're within 2 years after license expiration, it appears that you may still renew tho you may not operate. NPRM above proposes to reduce this period to 6 months.

# ARRL Files Petition for Rulemaking with FCC to Create New MF Band at 472-479 kHz

At the 2012 World Radiocommunication Conference (WRC-12), delegates approved Agenda Item 1.23: a 7-kilohertz-wide secondary allocation between 472-479 kHz for the Amateur Radio Service, with a power limit of 5 W EIRP (or 1 W EIRP, depending on location). Before this portion of spectrum is made available to radio amateurs in the US, the FCC must first approve its use and amend its rules to reflect the change. As
